The Toledo Gem and Rockhound Club (TGRC) is pleased to welcome the hard-working leaders and members of the Midwest Federation for the MWF annual convention. Although we do not yet have enough details to offer a registration form, the rough outline of events is as follows.

The convention will be held on Friday, Sept. 10<sup>th</sup> through Sunday, Sept. 12, as will our annual TGRC Gem Show. The convention hotel will be the Holiday Inn Express & Suites, 2150 E. Wooster Street, in Bowling Green, Ohio.

The MWF delegate and executive meetings on Saturday, as well as the banquet and awards dinner Saturday night, will be held at the conference hotel. There will be a Friday night social as well, but the location for that has not yet been determined. Field trips have yet to be determined.

The Holiday Inn Express has reserved a block of 25 rooms at a rate of \$99 per night (negotiated from \$162!). Call 419-353-5500, and mention that you are with the MWF when you make your reservation. It is a big weekend for Bowling Green; our show and the annual Black Swamp Arts Festival will have the town filled. So make reservations early.

The TGRC show will be held at the Pavilion of the Wood County Fairgrounds, 13800 W. Poe Road, in Bowling Green. Show hours will be Friday from 2 to 8 p.m. (with early bird hours from noon to 2 p.m.), Saturday from 10 a.m. to 6 p.m., and Sunday from 11 a.m. to 5 p.m.

Forms for club delegates, and for people wishing to enter a competitive exhibit at the show, are in this issue on pages 4 and 5. As soon as final arrangements are made, conference registration forms (in which you specify which activities you'll be participating in), as well as further details, will be posted on the MWF website and distributed by email to clubs. **STAY FOR THE ARTS FESTIVAL AND ACTIVITIES!**

You'll go to Bowling Green, Ohio, to attend the conference and snap up rocks at the Toledo Gem and Rockhound Club show, sure. But these aren't the only activities in town, not by a long shot.

To begin with, there will be the music and art celebration that's making us all call early for our hotel reservations before they get booked! The Black Swamp Arts Festival includes two art shows, a juried show and the Wood County Invitational Art Show. Musical acts range from R&B to rockabilly to jazz. Local teens take part in the BG Rotary Chalk Walk, creating elaborate sidewalk art, and in the musical Beats on the Street program, competing to win money for their high schools' art and music departments. The Wood County Park District includes more than 1,100 acres of outdoor sights and activities, including the Black Swamp Preserve, which is in Bowling Green itself. The preserve is wheelchair- and bicycle-accessible, and has indoor restrooms. It has pollinator gardens, grass trails, and paved access to the Slippery Elm Trail, a 13-mile bike path.

Food will absolutely not be a problem. The town is the site of Bowling Green State University, so food for all palates and price ranges can be found, both on campus and in the shopping districts.

There are chain stores in Bowling Green, but also local stores like Coyote Beads & Jewelry (open

### **DEADLINE: November 1, 2021**

**The American Federation of Mineralogical Societies ("AFMS") will hold its annual convention in January 2022, thereby shortening up the timeline and number of entries available to submit for competition.** It will soon be time to gather your bulletin items to send for competition in the MWF Bulletin Editors' Contest, sponsored by the Midwest Federation of Mineralogical and Geological Societies ("MWF").

The 2022 Bulletin Contest packet will be posted on the MWF website, <http://www.amfed.org/mwf>, and contains the forms and instructions needed to enter your club's bulletin and the work of your authors. Please read this entire article for specific rules. Also, please note that I prefer entries be submitted via e-mail, but paper copies will be accepted.

### **Summary of General Rules**

The author and editor of the item must be a member of the club whose editor is submitting the item to the contest.

All entries must have been originally published during January 1 through September 30, 2021 only. They should not be revised in any way.

All entries (except Special Publications) must have been published in the club bulletin.

The subject matter must be related to some phase of the earth science hobby.

There should be no copyright violations.

Only one entry is allowed per author, per class, per club, except that any number of special publications may be entered. (See below for specific information for contest submissions.)

Bulletins:

- Mini Bulletins (6 pages or less)
- Small Bulletins (7 to 11 pages)
- Large Bulletins (12 pages or more)
- New Editors (any number of pages)

Articles/Features/Poetry/Drawings:

- Original Articles, Adult
- Original Articles, Adult Advanced
- Original Articles, Junior (ages 12-17)
- Original Articles, Junior (under age 12)
- Original Adult Poetry
- Original Junior Poetry
- Written Features
- Drawn Features
- Special Publications

**Entries of bulletins and special publications** must be "original printings" exactly as distributed to the club members. (Exception: If the item was distributed only by electronic mail or on CD/DVD, then a "hard copy" must be submitted on one-sided paper.)

**Entries of articles, poems, and features** should be sent as actual pages from the bulletin. Photocopies of an entire page are acceptable if the page includes the bulletin title, date, and page number. Be sure to include any continuation pages.

If a club belongs to more than one regional federation, the editor must pick only one federation contest to enter. If a club has more than one bulletin, only one may be entered in competition.

The act of entering the contest constitutes the granting of permission to the MWF, the AFMS, and their member clubs to reprint any materials entered, provided the author and the name and date of the original publication are properly credited.

### **How to Enter the Contest**

The MWF contest uses basic AFMS contest rules with some modifications, as shown below. The complete AFMS rules and some interesting essays by expert judges are posted on the AFMS website at: <http://amfed.org/editor/BEAC/contest.htm>.

Read all the General Rules, Additional Rules, and Score Sheets that pertain to the item(s) to be entered.

Select the proper score sheet for each item. Make as many copies as needed for all intended entries. Fill out the information at the top of each score

sheet, down through the CLUB CITY/STATE/ZIP line. Do not mark anything below that line – the BEAC or the judges select which criteria to use.

Use the fillable forms on the website. If you cannot use the online forms, please print clearly and include the 5-digit or 9-digit zip code in the editor's address, since contest results may be mailed there. The club's address is optional except for city and state.

**To enter your bulletin**, I prefer you send electronic copies. Only one copy is needed if sent electronically. If you must send paper:

Submit two copies of the bulletin; **this year only**, the month selected is your choice.

Attach the proper score sheet with the required information to each of the copies.

**To enter anything other than your bulletin**, I prefer you send electronic copies. Only one copy is needed if sent electronically. If you must send paper:

Submit two copies of each selection.

Attach the proper score sheet with the required information to each of the copies.

**If the author is a junior member, be sure to include the age of the author at the time of the publication so that the entry may be judged appropriately.**

The BEAC Chairman will accept either e-mailed submissions or those sent via U.S. mail.

**E-mail your PDF entries**, no later than November 1, 2021, to the BEAC Chair at [mamamar7880@outlook.com](mailto:mamamar7880@outlook.com). Please put "BEAC Competition" in the subject line.

### Conventions



meeting June 17<sup>th</sup>. He is responsible for the following committees: International Relations – Chairman Bob Jones, Program Competition – Chairman Darrell Watkins, Safety – Ellery Burrows, Chairman, and Historian Jennifer Haley. He will have more to report in Toledo after attending the meeting in Wyoming.

**MWF Logo:** Martha Miss had noted that there are various versions of the MWF logo being used on the newsletter, directory and membership cards. She asked why we were not being consistent. J.C. Moore added that the 50<sup>th</sup> Anniversary Program had described the logo (insignia) and showed what was then considered the official one. Brad Zylman said he couldn't find a good copy a few years ago. The official one will need to be sent to Cindy Root for the website so members/clubs can use it. Valerie will need it for the newsletter. The logo has not been registered for a copyright. A black and white version is needed. Sandy reminded that we will need to maintain the scale so it isn't squashed. Sharon Marburger suggested that the final determination for the logo be put in the newsletter. Martha agreed to do that. It was noted that if an editor wants to use the logo, it needs to be a high resolution image. The website might have a lower resolution.

**Funds to pay deficit:** Sandy Fuller reported that in the past, the Endowment Fund was used to pay part of the dues to the AFMS, which is \$1.00 per member regardless of age. This was covering the last 25-cent increase plus 50 cents for each junior. Now it is also covering the subscriptions to Mini Miners Monthly. With interest rates almost zero, not enough interest is being generated to cover these expenses. We are not allowed to touch the principal of the fund, only the interest. There are essentially no earnings to cover either of these expenses next year.

J.C. Moore moved to pay the shortage for these funds from the accumulated reserves instead of the Endowment Fund for 2022. David Rich seconded the motion. Sandy noted that last year the expense was \$2,075 for the AFMS dues and \$650 for the Mini Miners Monthly, which came to approximately \$2,725. We have that much in the accumulated reserves to cover it this year. The ayes approved the motion with no nays.

There was a question about **Geology 365**. Sandy explained that an ad hoc committee of the AFMS is in negotiations with the person behind it. He had added clubs and information without permission. They are attempting to get him to stop or do it in conjunction with the AFMS. He is proposing to bring in clubs later. Right now it is free. More information will be available after the AFMS meeting. Anyone who would like to get involved in the process can contact Sandy.

Andrea Morehead, Chairman of Supplies, asked about **making manuals electronic**. She noted that there were different logos on manuals in her supplies. Some of the manuals need their cover sheets updated. Martha Miss asked her to be sure to use the approved version going forward. Andrea wanted to update the cover sheets when documents are updated.

The nature of .pdfs is that they are available for download. She asked about charging for downloads if electronically available. Sometimes she doesn't know if things have been updated. We need to have everything available to our members. She wondered about approval to scan in manuals so they are available to download. Cindy has the permission link for the storage of items on the cloud. She will give Andrea permission. Should we pay someone to scan the manuals? Cindy said she doesn't mind doing it. Andrea said she actually has very few requests, most of the requests are for directories.

J.C. Moore noted that several years ago Dennis Westman talked about getting things into electronic format. Scanning might have an initial cost, but printing and mailing costs would be saved. Sandy Fuller added that the uniform rules are on the AFMS Website. Old copies confuse people and could be destroyed. The club leadership manual and juniors manual need to be on the website. Cindy noted that she has not added any manuals. We can still have some physical copies to sell at shows. Brad added that anything on the website should be in .pdf format. A fee would require setting up e-commerce and use of credit cards which brings up safety issues. Catherine appointed a committee consisting of Andrea, Brad, Sandy, Sharon, and Cindy to look into this and report back at the convention in September.

**Name tags:** Andrea said she has had a rough time finding anyone to replicate our name tags and position plates. She can't find any local vendors. They are considering going to Google Suites. When they move, we will need a new host. Google Suites is free to non-profits. We will have to get a new domain name and set it up on Google Suites, which Cindy isn't familiar with. Brad has used it in a limited capacity. Cindy had been planning to redo the website using Expression Web.

She asked for permission to contact Marty Hart to get us separated. She needs to get a domain name. She will need to get proof that we are a registered non-profit. Sandy said she can get that from the registered agent in Minnesota for \$15. Sandy will get that and send it to Cindy. Cindy is ready to start the procedure whenever Sandy can get that to her. She asked for permission to separate from the AFMS site. She will talk to Marty Hart, AFMS Webmaster, now so we can be affiliated. We will keep the old website until the new one is up and running. AFMS is getting the software. Cindy and Sandy will work it out.

Brad Zylman asked about an operating procedures manual. He has a lot of questions and would like to discuss it further. It was noted we have an operating procedures manual, part of which has been updated.

Catherine Clevenz announced that because of the art festival near the Toledo show site, some people might want to look at rooms in Perrysburg, Ohio, which is about 15 minutes from Bowling Green, the site of the fairgrounds where the show will be held.

J.C. Moore moved to adjourn the meeting. David Rich seconded the motion. Catherine adjourned the meeting.

## WHAT WAS THE GREAT BLACK SWAMP?

The Great Black Swamp, for which the Black Swamp Arts Festival is named, was fascinating both geologically and ecologically. Here are excerpts from various sources that tell the story of the Great Black Swamp.

From “The Great Black Swamp” page of [saudervillage.org](http://saudervillage.org): “The Great Black Swamp, which covered approximately 1,500 square miles in Northwest Ohio and northeastern Indiana, formed as a result of the Wisconsin Glacier covering the land about 20,000 years ago. When the glacier retreated, it left a flattened surface covered with impermeable clay. Sand ridges were left behind that separated certain areas of the swamp from each other, and provided some higher ground . . . When the leaves from the trees and other plant material fell into the water, they decomposed and the water turned black. Thus the swamp became the Great Black Swamp.” [Editor’s Note: *Sauder Village is a living history museum and farm in Archbold, Ohio.*]

From Wikipedia’s “The Great Black Swamp”: “. . . it occupied what was formerly the southwestern part of proglacial Lake Maumee, a holocene precursor to Lake Erie. The area was about 25 miles wide (north to south) and 100 miles long, covering an estimated 1,500 square miles . . . the dense habitat and difficulty of travel through the swamp delayed its development by several decades. A corduroy road (from modern-day Fremont, Ohio to Perrysburg, Ohio) was constructed . . . in 1825. . . Travel in the wet season could still take days or even weeks. . .”

From “The Black Swamp: An Impenetrable Bog,” a flier published by Historic Perrysburg, Inc.: “Water, often up to the belly of a horse, stood on the surface until it evaporated in the hot summer months. When it rained, or thawed in the winter, it was water and muck. Much of the swamp was covered with an almost impenetrable forest of giant oak, sycamore, hickory, walnut, ash, elm, maple and cottonwood trees, except in a few prairie areas where limestone just under the surface would not support timber growth.

“Finally, in 1850, the Ohio legislature passed the first law regarding government support for drainage systems . . . with ditches deep enough to drain the swamp water into Lake Erie via the Maumee, Portage and other rivers. Individual farmers continued to dry out their fields by plowing trenches across them, using wooden troughs laid underground, and eventually with clay tiles and pipe introduced by European farmers. It took back-breaking labor and construction of one of the greatest underground drainage systems in the history of the world to create the productive farmland we now drive by and take for granted . . .”

From Wikipedia: “Gradually drained and settled in the second half of the 19th century, it is now highly productive farmland. However, this development has been detrimental to the ecosystem as a result of agricultural runoff. This runoff, in turn, has contributed to frequent toxic algal blooms in Lake Erie. . .”

From “Learning to Love the Great Black Swamp,” by Sharon Levy, from [undark.org](http://undark.org): “In spring, rains wash a pulse of nutrients off the surrounding

region's fertilized farms and send it . . . into western Lake Erie. And in summer, as water temperatures rise, *Microcystis* forms an iridescent mat over parts of the lake's surface. In early August of 2014, strong winds blew a lawn of cyanobacteria over Toledo's water intake, which lies just outside the Maumee's mouth. Tests showed that the city's water contained dangerous levels of microcystin, a liver toxin . . .

“. . .in the aftermath . . . William Mitsch, a wetlands expert and professor emeritus at Ohio State University, offered up a characteristically blunt solution. Harmful algal blooms have become chronic in western Lake Erie, he said, because of the wrong-headed way people manage the watershed. Mitsch proposed that a significant fraction of the region's rich cropland be taken out of production and converted to wetlands, which act as natural filters for the overload of nutrients now flowing from farm to river to lake. . .

“And yet, [Jim Moyer, Sandusky County Engineer] doesn't see large-scale wetland restoration as practical part of that solution. ‘I try to be realistic,’ he says. ‘In our county, agriculture is important. We have corn, soybeans and wheat, but also tomatoes, cucumbers, peppers, cabbage — high-dollar crops. Boy, they cannot tolerate any excess water.’”

From Wikipedia: “During the second half of the 20th century, efforts were undertaken to preserve and restore portions of the swamp . . . The Black Swamp Conservancy, founded in 1993, has also been involved in preserving former swamplands. They currently protect 17,600 acres spread throughout the Northwest Ohio region.”

**SCHOLARSHIP HONOREE DIGS DINOSAURS, STUDIES BIOLOGY, CLEANS UP AFTER PIPE BREAKS**

The MWF Scholarship Selection Committee has voted Joshua Mathews to be the 2021 American Federation of Mineralogical Societies' Scholarship Foundation Honoree for the Midwest Federation.

Mathews studied invertebrate paleoecology of Mississippian and Pennsylvanian deposits in Illinois, while earning degrees in geology and biology from the University of Wisconsin-Whitewater in 2003. He is a Ph.D. candidate in biological sciences at Northern Illinois University, and is Director of Paleontology at the Burpee Museum of Natural History in Rockford, Illinois. He has been very busy in doing clean-up work after the museum was flooded in February.

As the Scholarship Honoree, Mathews, coordinating with university faculty, will choose two students working on a master's degree or doctorate in the earth sciences. Each of those students will receive a scholarship grant from the MWF Scholarship Fund.
